

## Ski-Doo X Uncharted Society Contest OFFICIAL SWEEPSTAKES RULES

WINNER DRAW: October 27, 2025

AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES. By entering Ski-Doo X Uncharted Society Contest (the "Sweepstakes"), Participants (as defined below) automatically agree to accept and abide by these official rules (the "Rules"). All decisions of the Sponsor (as defined below) with respect to any aspect of this Sweepstakes, including without limitation the eligibility of entries, are final and binding on all Participants in all matters as they relate to this Sweepstakes.

## VOID WHERE PROHIBITED BY LAW

- 2) SWEEPSTAKES PERIOD. The Sweepstakes Period to enter into this Sweepstakes is for a limited time. Participant may enter the Sweepstakes as of October 1st, 2025 at 9:00 am ET until October 20 2025, 11:59 pm ET (the "Sweepstakes Period"). No entry received before or after the end of the Sweepstakes Period will be accepted.
- **SPONSOR.** The Sweepstakes is sponsored by Bombardier Recreational Product Inc. ("BRP" or the "Sponsor"), 726, rue St-Joseph, Valcourt, Quebec, J0E 2L0.
- 4) NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
- ELIGIBILITY. This Sweepstakes is open to legal residents of Canada and the United States (except for the residents in the states of New York, Alaska, Hawaii, Florida, and the U.S. territories), who have reached the age of majority in their country/state/province/territory of residence as of the date the Sweepstakes Period begins, who must have all applicable valid driver's license and who have a valid email address and provide valid contact information.

All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the Rules may be disqualified by the Sponsor, to his sole discretion, acting reasonably.

- 7) ONE ENTRY PER PERSON. Participants may only submit one entry using the same information.
- 8) DRAW. Sponsor will randomly draw, among the valid entries received, one (1) Participant (one "Winner"). Draw will be made at the Sponsor office located at 726 St-Joseph Street, Valcourt, Québec, J0E 2L0 on October 27, 2025.

Chances of being drawn as the Winner depend on the number of valid entries.

Decisions of the Sponsor in the drawing of the Winner and all matters relating to this Sweepstakes are final and binding.

Sponsor shall not be held responsible for any delays occurring for any reason outside of its control.

Sponsor is not responsible for failed attempts to notify the Winner.
- **10) PRIZE DELIVERY.** A Sponsor representative will contact the Winners to make the Prize delivery arrangements.

## 11) PRIZE. one (1)Winner will be drawn:

One (1) 2-day Uncharted Society adventure to Imago Village in Saguenay, Quebec, Canada, for two (2) people, with a value of up to \$6,000. Prize in local currency and value may vary depending on Winner's point of departure. Any difference between maximum value and actual value will not be awarded. Prize includes lodging, meals, transportation to and from the experience, guided tour for the duration of the experience, two electric snowmobiles (gas snowmobiles are also available upon request), and the safety equipment necessary.

Prize must be booked and take place before March 31, 2026, and dates are subject to space and availability. Prize trip must be completed before the date specified and will otherwise be forfeited. Sponsor reserves the right to modify the trip. Prize is not transferable.
